

What are the EPA regulations for underground storage tanks?

In 2015, EPA revised the underground storage tank (UST) regulations. Below you will find the requirements for inspections and testing. Beginning on October 13, 2018 owners and operators must conduct walkthrough inspections at their UST facility. The walkthrough inspection must meet one of the following:

Why do storage tanks need regular inspections?

To review, monthly routine inspections are an integral part of maintaining the integrity and reliability of storage tanks. By adhering to the recommendations provided by API 653 and implementing a diligent inspection program, tank operators can detect and address issues before they escalate into more significant problems.

How often do you need a tank inspection?

Do UST systems need annual inspections?

One of the requirements of the 2005 Energy Policy Act was establishing annual inspections of your UST system. In 2015 EPA revised their original 1988 regulations to include the annual inspections as well as many other new testing and inspection requirements, such as the 30-day walk through inspections.

Are underground storage tanks covered by UST regulations?

Only those tanks that meet the definition of an underground storage tank (UST) system are covered by the UST regulations. Aboveground storage tanks (ASTs) are subject to other federal, state, or local regulations. Most ASTs need to meet U.S. EPA's Spill, Prevention, Control, and Countermeasure (SPCC) requirements (40 CFR, Part 112).

When did EPA start regulating underground storage tanks?

In 1984, Congress directed the U.S. EPA to develop regulations for underground storage tank systems. EPA issued federal regulations, effective December 1988, that delegate UST regulatory authority to approved state programs. States are the primary implementers of the UST program and may have requirements more stringent than the federal regulations.
