What happened at California's largest lithium-ion battery energy storage facility?

A fire at a California lithium-ion battery energy storage facility once described as the world's largest has burned for five days, prompting evacuation orders. The fire broke out on Wednesday at the 250MW Gateway Energy Storage facility owned by grid infrastructure developer LS Power in San Diego.

What happened at Gateway Energy Storage in San Diego?

The fire broke out on Wednesday at the 250MW Gateway Energy Storage facility owned by grid infrastructure developer LS Power in San Diego. A fire crew managed to get the blaze at the 16,000-square foot facility under control after around 24 hours, lifting evacuation orders that were made.

What happens if the energy storage system fails?

The energy storage system lacks effective protective measures, it may cause the expansion of battery accidents. If the energy storage device is arranged indoors, when the flammable gas reaches a certain concentration, it will explode in case of a naked fire, and more serious situation is the chain explosion accident.

Why is lithium battery energy storage system a fire hazard?

Storage system due to quality defects, irregular installation and commissioning processes, unreasonable settings, and inadequate insulation. On 7th March 2017, a fire accident occurred in the lithium battery energy storage system of a power station in Shanxi province, China.

What causes a fire accident in energy storage system?

According to the investigation report, it is determined that the cause of the fire accident of the energy storage system is the excessive voltage and current caused by the surge effect during the system recovery and startup process, and it is not effectively protected by the BMS system.
