Storage projects are remunerated according to market rules, as the production facilities that inject electricity into the public network. The implementation of energy storage projects by public entities is subject to public procurement rules, requirements and related regulations.

What is the new legal framework for energy storage?

In order to attract further investment and speed-up implementation, the new legal framework, which was published in the beginning 2022, provides a framework for standalone energy storage, subject to the previous control procedure, and to be owned by third parties who are separate from the power plant developers.

Bulgaria's Ministry of Energy announced two tenders to add 1,425 megawatts (MW) of renewable energy to the grid and 350 MW of battery energy storage system (BESS) projects. The main goal of the investment is to increase the share of clean energy in Bulgaria's energy mix on its way to climate neutrality.

On 21 August 2024, the Bulgarian Ministry of Energy opened a tender procedure for National infrastructure for storage of renewable energy (RESTORE) for granting stand-alone battery energy storage system (BESS) tender funded under the EU's Recovery Resilience Facility (the "Procedure"). The deadline for submitting applications will be 17:00 on 21 November 2024.

The six new BESS projects were amongst 1.9GWh of energy storage projects awarded grant funding in a recent tender called PERTE (Spanish strategic projects for the economic recovery and transition, in English) and will receive a total of EUR37.5 million (US\$41 million) in funding towards their deployment.
