

National development of energy storage industry

What is the 'guidance on accelerating the development of new energy storage'?

Since April 21, 2021, the National Development and Reform Commission and the National Energy Administration have issued the 'Guidance on Accelerating the Development of New Energy Storage (Draft for Solicitation of Comments)' (referred to as the 'Guidance'), which has given rise to the energy storage industry and even the energy industry.

What are the Development Goals for new energy storage in China?

The plan specified development goals for new energy storage in China, by 2025, new energy storage technologies will step into a large-scale development period and meet the conditions for large-scale commercial applications.

What is the implementation plan for the development of new energy storage?

In January 2022, the National Development and Reform Commission and the National Energy Administration jointly issued the Implementation Plan for the Development of New Energy Storage during the 14th Five-Year Plan Period, emphasizing the fundamental role of new energy storage technologies in a new power system.

How will new energy storage technologies develop by 2030?

By 2030, new energy storage technologies will develop in a market-oriented way. Newer Post NDRC and the National Energy Administration of China Issued the Medium and Long Term Development Plan for Hydrogen Industry (2021-2035)

How has energy storage been developed?

Energy storage first passed through a technical verification phase during the 12th Five-year Plan period, followed by a second phase of project demonstrations and promotion during the 13th Five-year Plan period. These phases have laid a solid foundation for the development of technologies and applications for large-scale development.

What is the 'guidance' for the energy storage industry?

Based on the above analysis, as the first comprehensive policy document for the energy storage industry during the '14th Five-Year Plan' period, the 'Guidance' provided reassurance for the development of the industry.

The recent development of the UK's energy storage industry has drawn increasing attention from overseas practitioners, achieving significant progress in recent years. According to Wood Mackenzie, the UK is expected to lead Europe's large-scale energy storage installations, reaching 25.68 GWh by 2031, with substantial growth anticipated in 2024.

At present, some relevant standards for corporations and industry have been established and published.

The cost reduction in the new energy storage process has surpassed industry expectations, along with the rapid pace of development. In March 2022, the National Development and Reform Commission and the National Energy Board introduced the implementation program for new energy storage development under the 14th Five-Year Plan.

In July 2021, the National Development and Reform Commission (NDRC) and the National Energy Administration (NEA) jointly published the "Guidance on Accelerating the Development of New-Type Energy Storage," which aims for the installation of 30 GW of new-type energy storage capacity and the transition from early commercialization to large ...

On June 5, the Guangdong Provincial Development and Reform Commission and the Guangdong Provincial Energy Bureau issued Measures to Promote the Development of New Energy Storage Power Stations in Guangdong Province, which mainly proposed 25 measures from five aspects: expanding diversified applications, strengthening policy support, improving ...

New operational electrochemical energy storage capacity totaled 519.6 MW/855.0 MWh (note: final data to be released in the CNESA 2020 Energy Storage Industry White Paper). In 2019, overall growth in the development of electrical energy storage projects slowed, as the industry entered a period of rational adjustment.

ESRA unites leading experts from national labs and universities to pave the way for energy storage and next-generation battery discovery that will shape the future of power. Led by the U.S. Department of Energy's Argonne National Laboratory, ESRA aims to transform the landscape of materials chemistry and unlock the mysteries of electrochemical phenomena at the atomic scale.
