What companies trade in electricity in Zambia?

Private companiesalso trade in electricity in Zambia. The largest of these, Copperbelt Energy Corporation Plc (CEC), buys electricity primarily from ZESCO and sells it to the various mines in the Copperbelt Province. It also operates its own generators, most of which run on fossil fuels.

What does the Electricity Act do in Zambia?

The Electricity Act regulates the generation, trans-mission, distribution and supply of electricity to enhance the security and reliability of electricity sup-ply in Zambia. It codifies the rules on tariff setting and introduces the concept of intermediary power trading, a concept that was missing from the previous regulatory framework.

Zambia and the Democratic Republic of Congo (DRC) want to use the 70% of the world"s cobalt reserves in their subsoil for the local manufacture of batteries for electric vehicles.
